



## NWYRA WAIVERS

Before Membership with NWYRA is complete, the Parents/Legal Guardians of the Contestant must acknowledge they have read, fully understand, and accept these Waivers listed below by checking the box at the bottom of on-line membership titled **“By checking this box, you agree to the above terms and conditions”**

### **1. RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT:**

Northwest Youth Rodeo Association (“NWYRA”) does not guarantee the safety of your minor child or legal ward (“Contestant”). You acknowledge that rodeo is a dangerous sport that could result in death. You agree that on behalf of the Contestant named herein, you hereby give permission for them to participate in the NWYRA rodeos completely at their own risk for injuries, death, dismemberment, or property damage that may incur. You agree that you are responsible for all costs incurred for injuries or property damage that may incur and that you are covered by medical coverage that is currently in force. You agree that you are responsible for the negligent acts of the Contestant named herein, yourself, your family members, legal guardians, friends, personal representatives, assigns, heirs, and animals in your party (“Contestants Party”), and that Contestants Party is covered by liability insurance currently in force. You agree to be responsible for any financial loss in relation to the theft or damage to your tack, equipment, vehicles, trailers, animals, and any other related item while engaging in the events/activities of the NWYRA. You hereby agree that the Contestant named herein and Contestants Party shall not bring any claims, demands, legal action and legal liability against and will hold harmless and discharge the NWYRA, its officers, directors, members, contracted persons, insurers, sponsors and the rodeo grounds in relation to; participation in the events/activities of the NWYRA, any economic and non-economic losses due to bodily injury, death, or property damage sustained by the Contestant named herein, you or your family members, to include, but not limited to the riding, handling of horses, cattle, goats, sheep or other related live stock or equipment utilized while participating in the events/activities of the NWYRA.

### **2. AUTHORIZATION FOR RELEASE OF PHOTOS:**

You hereby give NWYRA the authority and permission to photograph the Contestant named herein. NWYRA may use the photographs for marketing, educational, and promotional materials including social media and websites. You acknowledge that NWYRA has the right to use and publish all images. You release NWYRA from any claims for any issue connected to photographs used. You understand that you will not receive any money in connection with allowing use of contestant’s photographs.

### **3. SOCIAL MEDIAL POLICY:**

As a condition of membership of NWYRA the Contestant named herein, yourself, your family members, legal guardians, friends, personal representatives, assigns, heirs in your party (“Contestants Party”) agree not to post on social media comments about NWYRA that are inaccurate, detrimental, threatening, harassing and/or derogatory whether directly or indirectly. This includes pictures and videos that might cause embarrassment of themselves, to fellow contestants, the NWYRA and the NWYRA sponsors. Any written posts, comments, pictures, or videos found will cause disciplinary action by the NWYRA Officers/Board of Directors.
